I. Call to Order:

- A) Invocation: Chairman Pinckney called the meeting to order at 11:00 a.m. followed by the Invocation, the Pledge of Allegiance and a quorum determination. Chairman Pinckney announced new Board Member, Susan Milliken of the James Island Public Service District, and welcomed those present at today's meeting.
- B) Announcement of Proxies: Mr. Saxton for Mayor Green; Ms. Morgan for Rep. Jefferson; Rep. Hartnett for Rep. Landing; Mr. Case for Mr. Pryor; Ms. Redick for Rep. Robbins; Ms. Clark for Mayor Summey; Mr. Fekrat for Mr. M. Williams
- II. Consideration of Minutes: February 27, 2023 Board Meeting

Mr. Dennis made a motion to approve the February 27, 2023 Meeting Notes as presented.

Ms. Anderson seconded the motion. The motion was unanimously approved.

III. GetConnectedSC Broadband Initiative Presentation – Mike Shealy, SC Department of Administration

Ron Mitchum, Executive Director, introduced Mike Shealy, SC Department of Administration. Mr. Shealy delivered a presentation on the GetConnectedSC Broadband Initiative. He discussed social media noting it is the primary method of communication for most of today's society. Mr. Shealy stated that broadband is so influential, that it is now considered "essential infrastructure." He discussed the results of research regarding age, class, racial & ethnic and community differences. He discussed the US Census Bureau table noting the lowest percentages of Internet subscriptions per county and the highest raw number of underserved households for Internet subscriptions per county. Mr. Shealy discussed funding and the organizational infrastructure as well as the areas of need in the state of South Carolina. He explained the "BEAD" program (Broadband Equity, Access & Deployment Program), the program's objective, funding pool, priorities and other key features. He discussed the survey and the SC Road Show. Mr. Shealy addressed questions and comments. Andrea Kozloski, Deputy Director of Operations and Support, encouraged survey participation and sharing with as many individuals in the Tri-County region as possible. The Board of Directors received the GetConnectedSC Broadband Initiative Presentation as information.

IV. BCD 2040 Rural Long Range Transportation Plan (RLRTP) Amendment – Request for Approval – Sarah Cox

Sarah Cox, Senior Transportation Planner, presented the BCD 2040 Rural Long Range Transportation Plan (RLRTP) Amendment. She discussed, in detail, the proposed amendment to include the SCDOT's Strategic Ten-Year Asset Management Plan (STAMP) System Performance Report 2022 which reports on the progress made by the agency over the first performance period (2018-2021) and establishes updated baseline conditions and performance targets for the new performance period (2022-2025). Those are as follows: highway safety; infrastructure conditions (pavement & bridge); system reliability & freight movement; and congestion management & air quality improvement program. Ms. Cox acknowledged Erin Porter with SCDOT, who was in attendance at today's Board meeting, and addressed questions and comments.

Mr. Dennis made a motion to approve the BCD 2040 Rural Long Range Transportation Plan (RLRTP)

Amendment as presented. Rev. Reid seconded the motion.

Mr. Brewer and Ms. Massey abstained. The motion was approved.

V. FY24-FY25 Rural Transportation Planning Work Program (RPWP) - Request for Approval - Sarah Cox

Ms. Cox presented the FY24-FY25 Rural Transportation Planning Work Program (RPWP). She noted that the RPWP provides a two-year work program for transportation-related planning activities to be undertaken by BCDCOG staff. The RPWP program of work includes goals, objectives and tasks for the prescribed fiscal years that reflects legislative requirements under the planning rule updates to federal surface transportation regulations, with changes adopted in the Moving Ahead for Progress in the 21st Century Act (MAP-21), the Fixing America's Surface Transportation Act (FAST) and the Bipartisan Infrastructure Law (BIL)/Infrastructure Investment and Jobs Act (IIJA) passed in November 2021 which provides five years of continued funding for surface transportation infrastructure planning and investment. Ms. Cox explained that the proposed RPWP continues to organize work activities within four focus areas: Program Administration & Support; Rural Short-Range Transportation Planning; Rural Long-Range Transportation Planning; and Rural Transportation Improvement Program. She reviewed the proposed adjustments in detail and noted that, pending no substantive comments and Board approval, the finalized RPWP will be submitted to SCDOT, FHWA and FTA in advance of FY24 which starts July 1, 2023 through June 30, 2024. Ms. Cox addressed questions and comments.

Mr. Boykin made a motion to approve the FY24-FY25 Rural Transportation Planning Work Program (RPWP) as presented. Mr. Dennis seconded the motion.

Mr. Brewer and Ms. Massey abstained. The motion was approved.

VI. Financial Status Report/Revolving Loan Fund Report - Robin Mitchum

<u>Financial Status Report</u>: Robin Mitchum, Deputy Director of Finance and Administration, presented the Financial Status Report consisting of the Statement of Revenues and Expenditures for the period ending February 28, 2023. The report depicts unexpended funds of \$418,476.57. Ms. Mitchum stated that the agency remains in good shape and that no issues are anticipated. She addressed questions and comments. The Board of Directors received the Financial Status Report as information.

Revolving Loan Fund Report: Ms. Mitchum presented the RLF activity report as of March 31, 2023. She noted that all loans are current. Ms. Mitchum discussed the Revolving Loan Fund Activity noting that funds available for lending in the BCDCOG Revolving Loan Fund are \$1,246,761.24 and funds available for lending in the North Charleston Revolving Loan Fund are \$241,863.68 for a total of \$1,488,624.92 available for lending. The Board of Directors received the Revolving Loan Fund Report as information.

VII. General Public Comments

There were no General Public Comments; however, Board Member and City of Charleston Councilmember Caroline Parker discussed Rethink Folly Road. It was noted that discussion should be held further during a CHATS Policy Committee meeting. Jan Anderson, Board Member and City of Isle of Palms Councilmember thanked and commended all jurisdictions who responded to the incident that occurred on Good Friday; she noted that a dangerous situation was diffused and the community was kept safe. Board Member and Town of Lincolnville Mayor, Enoch Dickerson, addressed members of the SCDOT regarding fatalities at Lincolnville Road.

VIII. Executive Director's Time

Mr. Mitchum updated the Board of Directors on the contractor change with CARTA. He stated that Frank Rainwater will deliver a demographic presentation at a future meeting. Mr. Mitchum noted that an SCDHEC regional meeting is being scheduled and that a letter is out encouraging MAC participation. He stated that "One Region" continues to move forward and the RIA SCIP grant announcements should be made soon. He noted that work continues on the update to the long-range transportation plan for CHATS and staff is waiting to see how the urban census designation will affect future funding levels. The Secretary has committed to a minimum funding level for the BCDCOG rural areas. Mr. Mitchum addressed questions and comments. The Board of Directors received Mr. Mitchum's report as information.

IX. Chairman's Time

Chairman Pinckney commended Mr. Mitchum and staff for the quality of service provided for the region. He thanked everyone for attending today's meeting.

X. Adjourn

There being no further business before the Board, Chairman Pinckney adjourned the meeting at 12:05 p.m.




US Population Pyramid

The age distribution of the US population has shifted significantly as the 'baby boomers' age; the median age has increased from 28 in 1970 to 39 in 2020




SC Population Pyramid



The state's population growth over the past twenty years was driven by in-migration; deaths exceeded births in 2021



South Carolina Projected Population Change, 2020 - 2030 Horry, York, Spartanburg, Greenville, and Berkeley are expected to experience the highest growth


POPULATION CHANGE BY COUNTY FROM 2020 TO 2030


TOTAL POPULATION BY COUNTY, 2030



SC Population by Age Group


Population in the 65 plus age range is projected to surpass the under 0-17 age range by 2027

SC POPULATION BY AGE RANGE Estimates and Projections







SC Employment by Industry



US UNEMPLOYED PERSONS PER JOB OPENING



Private sector wage growth has far outpaced the public sector since the pandemic; competition for workers is driving up wages, and government sectors are lagging behind


US WAGE AND SALARY GROWTH





BCD 2010 and 2030 Population








2030 POPULATION PYRAMID

Subject: Amendment to the FY 2021- 2027 RTIP

BCDCOG Rural TIP Amendment

Attached for your review and approval is an amendment to the FY 2021-2027 Rural Transportation Improvement Program (RTIP). This amendment is advertised for public comment through July 6th, 2023. Subject to no comments and the approval of the Board, additions or adjustments to projects will be transmitted for inclusion in the State TIP (STIP).

RTIP Amendments

AMENDMENT #17 - JUNE 20, 2023

Projects Exempt from Guideshare

SCDOT's new implementation plan for the delivery of improvements to the I-26 corridor from MM154 to MM187, reduces project programming from three (3) segments to two (2) segments as follows:

- 1. I-26 Widening (MM165 to MM176): At the request of SCDOT, delete/remove project from the TIP, since project's extents are covered or absorbed by the adjustments made in items 2 & 3 below.
- 2. I-26 Corridor Improvement (MM154 to MM172): At the request of SCDOT, add new project for the improvement of mainline I-26 from MM154 to MM172, and program \$30.54M for preliminary engineering, \$15M for right-of-way and \$280M for construction, for a total project cost of \$325.54M.
 - Add \$5,000,000 (PE) NHPP funds for preliminary engineering in FY2023
 - Add \$25,540,000 (PE/AC) NHPP funds for Advanced Construction in FY2023
 - Add \$12,770,000 (PE/ACC) NHPP funds for Advanced Construction Conversion in each of FY2024 and FY 2025
 - Add \$7,500,000 (R) NHPP funds for right-of-way in FY2026
 - Add \$7,500,000 (R/AC) NHPP funds for Advanced Construction in FY2026
 - Add \$7,500,000 (R/ACC) NHPP funds for Advanced Construction Conversion in FY2027
 - Add \$280,000,000 (CON) NHPP funds for construction in FY2028+
 - o Add \$69,428,571 (CON) NHPP funds for construction in FY2030
 - Add \$210,571,429 (AC) NHPP funds for Advanced Construction in each of FY2030
 - Add \$92,571,429 (ACC) NHPP funds for Advanced Construction Conversion in each of FY2031 and FY2032
 - Add \$15,428,571 (ACC) NHPP funds for Advanced Construction Conversion in FY2033
 - Add \$10,000,000 (ACC) NHPP funds for Advanced Construction Conversion in FY2034
