### VIII. CHATS Policy Committee meeting update

The original approval of \$1.5M based on the original application to CHATS has not been amended (approved) into the State's STIP. As such, in an effort to move forward with the remaining application to CHATS it should be approved first. This process will take time and there is no guarantee of any other money from CHATS.

### IX – Next Steps – Conceptual Estimate (Reveer Group)

Rhett Reidenbach made a presentation detailing the proposed bike/ped improvement sections, cost estimates, and accident/census data. He noted that the accident and census data make a case for prioritizing the sections starting at the northern end (Ellis Creek/Section 1) and the moving southward section by section. After discussion that included questions regarding sidewalk/MUP width options, stormwater concerns, etc., Councilmember Jackson asked if stormwater concerns can be addressed concurrent with the bike/ped engineering and construction work. Rhett said there is no reason why it couldn't. Devri added that it was very important that a decision is made that can give her office direction on how to proceed with money currently allocated. Brown-Crouch made a motion to begin at Section 1, Fred Whittle seconded and it approved unanimously. The committee has given Charleston County direction on moving forward to get a survey scope of Section 1 going southward which will include options and costs.
